Home Visits, Outdoor Communion, Special Masses Complement Our Live Broadcast.

Proclaim! TV broadcast area pastors and Eucharistic ministers are accompanying the return to public Masses with in-person opportunities to receive Holy Communion. During Communion visits, shut-ins say how appreciative they are of our live Masses that spiritually bring God's Word and the Word Made Flesh into their homes and apartments. The protection of residents' health in nursing care homes currently prevents communion call visits.

Please contact your home parish to learn when a home Eucharistic visit might occur and what opportunities exist for the outdoor reception of Holy Communion.

The Cathedral Communion distribution station is at the parking lot of the St John Gualbert Cathedral Activities Center (110 Adams Street). From 12:30 to 1:00 PM, Father Jim Crookston and Eucharistic Ministers with help by greeters will be ready for vehicle drivers and their passengers. They enter from Adams Street the Holy Communion drive-through lane, receive instructions, move to the in-vehicle Holy Communion station, receive the Eucharist, offer a short prayer, and exit onto Railroad Street. Walk-up communicants proceed to the gate at the walkway of the Center of Adams Street. Dozens of area Catholic come for Communion after watch our Proclaim! TV Mass.

July has two much anticipated and well attended times of prayer. We have adjusted the dates away from Sundays. Our annual Anointing of the Sick Mass moves from its usual Sunday afternoon celebration of Saint John Gualbert (July 12) to Monday, July 13, at 7:00 PM. Limited seating locations makes calling in necessary. Should requests for attendance at the Monday Mass exceed what we can safely accommodate, we will welcome worshipers to an additional Mass on Tuesday, July 14. Likewise, the Saint Anne Triduum moves to the weekday evenings of Monday, Tuesday, and Wednesday (July 27-29) at 7:00 PM. No advance call-in will be needed for the Triduum. Social distancing and face masks are required at all Masses at the Cathedral.
